MONTHLY HIGHLIGHTS REPORT



Corresponding VISP activities that have contributed to these achievements are included below each achievement.


VISP STRATEGIC OBJECTIVE

Select GOC Institutions, Policies and Systems at the National and sub national levels operationalized for effective implementation of the Victims Law.

R1. Improved GOC Strategic Management for Victims Law

Victims Unit's Functions Manual advanced

- Presented the Victims Unit's Functions Manual to the Victims Unit Directorate General, including Director Paula Gaviria and Mission Directors
- Created data sheets with functions and responsibilities of each position
- Once the Manual is defined and approved it will be adopted through a resolution, allowing the Victims Unit to eliminate temporary positions and open vacancy announcements for staff positions.

Direct municipal financing scoring mechanism designed and piloted

- IOM designed and piloted a scoring mechanism to identify municipalities to receive direct cooperation funds
- The scoring is done in four areas: development (demographics and social characteristics), public administration, economy, victims.
 Municipalities scoring above a threshold (large vulnerable populations, good public administration, lack of economic resources, high prevalence of victims)
- Results from the pilot are presented below:

R2. Improved GOC Rehabilitation Services that Strengthen Victims Capacity to improve their wellbeing

Comprehensive Health Program (PAPSIVI) training held

- Conducted training with consultants on Comprehensive Health Program (PAPSIVI) implementation, including theoretical and practical elements around psychosocial and integral health service provision
- Consultants and MOH officers will train the 126 teams in charge of implementing PAP-SIVI in 18 departments
- Designed PAPSIVI training content and methodology to be implemented in September and October
- Produced a video message with Colombian scholar Father Javier Giraldo, who makes recommendations to the local PAPSIVI implementation teams.

R3. Transitional Justice Processes Advanced

First of seven Reparations School department trainings held

- Coordinated a five-day training in Popayán for 35 persons from:
 - * Victims Unit reparations liaisons
 - * Governor and Mayor liaisons
 - * Land Restitution Unit staff
 - * VISP local staff
- Designed training agendas and material jointly with the Victims Unit and Reparations School
- Successfully solicited support from the ICTJ in expert transitional justice knowledge.

R4. Select GOC Institutions and Systems Accommodate the Specific Needs of Ethnic Groups and Women

Created historical memory initiatives with the Awá community (Nariño)

Jointly implemented activities with the Ministry of Culture and CNMH to create historical memory with the Awá community

Victims Unit Diversity Mainstreaming unit supported

- Presented a project to support the implementation of the Sub-committee's implementation plan
- Achieved participation from various national government entities responsible for diversity mainstreaming within the Victims Law
- Created a Victims Unit support team to mainstream diversity in registration and individual reparation processes, returns and the participation protocol.
